# बारह सौ करोड़ के मादक पदार्थ के साथ दो अफगानी गिरफ्तार

नई दिल्ली, 6 सितंबर।

मादक पदार्थों की तस्करी में लिप्त लोगों के खिलाफ दिल्ली पुलिस की विशेष प्रक्रोष्ट (स्पेशल सेल) ने बड़ी कार्रवाई की है। पुलिस ने दो अफगानी नागरिकों को गिरफ्तार किया है। इनकी निशनदेही पर, पुलिस ने 312.5 किलो मेथमफेटामाइन और 10 किलो हेरोइन जब्त की है, जिसकी कीमत अंतरराष्ट्रीय बाजार में करीब 1200 करोड़ रुपए आंकी गई है, जो अब तक की सबसे बड़ी बरामदी मानी जा रही है।

यह मादक पदार्थ दिल्ली से हरियाणा, पंजाब, हिमाचल और राजस्थान में आपूर्ति की जानी थी। पुलिस ने 312.5 किलो मेथमफेटामाइन और दस किलो हेरोइन जब्त की है कि यह नागरिकों द्वारा गिरफ्तार से जुड़ा मामला है। पुलिस का दावा है कि इस धंधे की कमाई के रूपए का भारत में आतंकी गतिविधियों में इस्तेमाल किया जाना था। तस्कर मादक पदार्थ एक स्थान से दूसरे स्थान पर महार्ही (लाजरी) बाहर में पहुंचता था।

विशेष अनुयुक्त एचीएस धालीवाल ने मंगलवार को बताया कि उपायुक्त पीएस कुशवाहा के नेतृत्व वाली एसीपी ललित मोहन नेंगे, हृदय भूषण, इंप्रेक्टर विनोद कुमार बड़ोला, अरविंद कुमार, एसआइ सुंदर गोतम और यशपाल सिंह की

टीम ने इस पूरे गिरह का पर्दाफाश किया है। गिरफ्तार किए गए दोनों अफगान नागरिकों के नाम मुस्ताक स्टार्निंग और रहीमुल्ला रहीमी हैं। कांधार और काबुल के रहने वाले हैं। पुलिस ने इन्हें कालिंही कुंज मेट्रो स्टेशन के निकटी मीठापुर रोड के पास से गिरफ्तार कराया। जांच करने पर नौ कट्टू में मेथमफेटामाइन पाई गई। इनकी निशनदेही पर ग्रेटर नोएडा में पार्क कार से भी मादक पदार्थ जब्त की गई।

यह विशेष अधिकारी ने दिल्ली के विवरण की अपील

पंजाब, हरियाणा, हिमाचल व राजस्थान में होनी थी आपूर्ति दिल्ली पुलिस का कहना है कि 3 सितंबर को सूचना मिला था कि मादक पदार्थ की खेप पहले तिमिलान्हू की राजधानी छेन्झई से उत्तर प्रदेश के लखनऊ लाई जाएगी और वहां से फिर दिल्ली के कालिंही में पहुंचेगी। इसके बाद मादक पदार्थ दिल्ली से हरियाणा, पंजाब, हिमाचल और राजस्थान में आपूर्ति की जाएगी। पुलिस ने रकोड़ा कार सवार दो अफगान नागरिकों को पकड़ लिया। एक के पास से 1,360 किलो और दूसरे के पास से 1.40 किलो हेरोइन बरामद हुई। बाद में दोनों से पूछतात के बाद पुलिस को महिंद्रा पिंकअप के बारे में जानकारी मिली।

इसके बाद एसडीएमसी टोल कालिंही कुंज के पास से ही पुलिस को उत्तर प्रदेश का पंगीकृत का पिंकअप भी मिल गया। पुलिस ने पिंकअप से 16 कट्टू सफेद पाउडर बरामद किया। जांच करने पर नौ कट्टू में मेथमफेटामाइन पाई गई। इनकी निशनदेही पर ग्रेटर नोएडा में पार्क कार से भी मादक पदार्थ जब्त की गई।
